School fees and levies are billed and issued on a monthly basis (from February to November) by email with payment due 14 days from date of invoice. The Year 5 and 6 Camp are at an additional cost. Parents will receive a Permission Slip with the details of the camp including costs from the teacher.

A 5% discount is offered on Tuition Fees & Capital Levy for full payment of fees and levies by 28th February, 2025. Please note there is no discount on the Resource Levy, Technology Levy, Bookpacks or Camps. See next page for fee table including the discount.

Payment Options

- Direct Debit is a preferred method of payment and forms are available from the School Office or the Parent Portal. Payments can be deducted weekly, fortnightly or monthly and spread over the school year (February to November) or full year (January to December).
- BPAY is another preferred method of payment. BPAY details are on your fee statement.

- If you receive a Centrelink payment, another option for paying your school fees is Centrepay. Centrepay is a bill paying service, free for Centrelink customers, through which deductions can be made from a customer's payment directly to Christ the King Catholic Primary School. Forms are available from the School Office or Parent Portal.
- BPOINT link details are on the Parent Portal. Use this link to pay your school fees by credit card.
- Eftpos and cash payments are accepted at the School Office. A receipt will be issued.

If you would like to pay your school fees by Direct Debit or Centrepay please use the Fee Calculation Worksheet on the Parent Portal to calculate the payment amount or alternatively contact the finance office for assistance.
